Foster Contract Agreement

As you read through this agreement please note that fostering a horse is a very large and important responsibility.. Also note that it can be very time consuming, and possibly expensive. A&A Horse Haven Inc. does appreciate all the help and plans to work hand in hand with the fosters that help us!

1. You agree to hold harmless A&A Horse Haven, its directors, board members, or volunteers, including any affiliate from and against all liability, causes of action, demand, judgments, and claims of any nature whatsoever arising from, by reason of, or connection of said horse.

2. You assume responsibility for the care of the horse you are fostering. You are responsible for food, water, shelter, basic medical care, and farrier services. Basic medical care is anything that isn't considered an emergency. You agree to set up routine veterinarian appointments if needed, and must keep an up to date coggins on said horse in your care. You also agree that A&A Horse Haven INC. or any affiliate may show up for scheduled and unscheduled visits to evaluate the horse in your care. _____initials

3. You agree that any expenses must be accompanied by detailed receipts and a log of what happened for each horse being fostered and must be approved by an A&A Horse Haven representative. _____initials

4. You must contact A&A Horse Haven or one of the representatives from the list provided , before a veterinarian is contacted for services on emergency and other issues that you cannot deal with on your own. _____initials

5. You will be given a list of contacts with their contact information in the order in which you are to call to contact someone. This way you will always be able to contact a representative from the list provided from the rescue at any time, and you must agree to do so.

6. You agree to contact A&A HOrse Haven with any questions, concerns, or issues that you are unsure of about the horse or horses that you are fostering. _____ initials

7. You Are responsible for damages to property or personal belongings if the horse that you are fostering causes any while in your care. A&A HOrse Haven will not be held responsible in the case that the animal gets out and causes said damage to property belonging to someone else or yourself. It is your responsibility to maintain and check the enclosure in which the horse is being kept while in your care. The enclosure must be safe from debris and any repairs must be properly fixed by the foster. _____ initials

8. If you are interested in adopting the horse that you are fostering or any other horse that is available at A&A Horse Haven you will have the first option to do so. As with any person who adopts you would pay an agreed upon amount per the adoption fee of the horse.

9. You agree that upon the horse becoming available for adoption that you will assist A&A Horse Haven with providing information on said horse and will be available to speak to potential adopters and give nothing but truth about the horse you are fostering in the case that you choose not to adopt the horse yourself. You should also within reason be able to work with the rescue to make appointments to set up a showing time for the horse that is available for adoption to the new potential adopters. _____ initials

10. In the case that you need to relinquish the foster ability of the horse you are fostering for any reason, and need us to find another foster or to come and take the horse back, we require if possible a notice ahead of time, if not as soon as possible and NO questions will be asked.

11. You are responsible for keeping a record of training, issues worked on and what you have done with the horse as well as any bad habits the you have noticed with the horse while you are fostering, and we ask that you be as truthful as possible. _____ initials

12. A&A HOrse Haven will not be held responsible for personal or medical bills or injury form foster horses if any occur, You must provide proof of medical insurance coverage, which will remain on file with only us. _____ initials

13. Foster applicants must get verbal or written permission from the rescue to use, ride, train, work or transport the horse in any way, to make sure the horse's condition is safe to do so.

14. We at A&A Horse Haven and our affiliates do not give a guaranteed date as to which any horse in foster will be ready for adoption, it is up to the rescue and the foster to make that determination together. Each horse has different needs and that date is never a guarantee, the foster needs to agree and be aware of that. _____ initials

15. You understand while in foster care, this horse may not be bred or sold. You understand that while fostering this horse is still property of A&A Horse Haven. You understand that no boarding fees or training fees will be paid for this horse at the time it is at your property.

I agree to and fully understand all the foster terms and conditions in this agreement provided by A&A Horse Haven, I agree to comply with all of the terms to the best of my ability that have been stated in the previous reading of the document.

The foster must also be aware that the above rescue deals with sick, emaciated, neglected, and abused horses, and will take into account that getting a horse back to proper weight and trying to heal what has been done to the horse may take in some cases a long time with a very lengthy recovery process.

Also if the foster has to move or move the horse being fostered the rescue must be notified of the correct address where the horse will be located. Also the foster must also make sure that the above rescue has a current phone number or form of contact for the foster.
